CLARIN Standards Committee: meeting report

 The CSC met on 18th of September in Budapest, at the CLARIN Annual Conference.

- 16 people were present, including a liaison to the BoD, Koenraad De Smedt.
- The Committee discussed the state of work, plans for future work, and housekeeping matters.



State of Work: past year

- GitHub repository within CLARIN-ERIC space has been opened
 - Code and documentation for the CLARIN Standards Guidance (still available in the old form under the old address: http://clarin.ids-mannheim.de/standards/; eventually to be moved under the clarin.eu domain) have been released
 - Several committee-internal projects have been defined
- Documentation for a liaison agreement between CLARIN-ERIC and ISO TC37SC4 "Language Resource Management" prepared at the end of 2016
- The agreement has been approved by the BoD and ISO, and is now in effect, with Andreas Witt as the Liaison Officer
 - within this agreement, work is being carried out at IDS Mannheim on making definitions from ISO TC37SC4 norms available to, and searchable by, CLARIN researchers
- Several members of the Committee have been involved in Work Package 4 (Standardization) of the PARTHENOS project

Future plans

- CSC approves of the proposal for a unified list of standards prepared (coordinated) by Hanna Hedeland (now a member) and will concentrate on developing it
 - To this effect, a sample proposal for text-based formats will be prepared by Piotr Banski and Jussi Piitulainen within two weeks
- CSC needs access to the information on area expertise of CLARIN members in order to be able to request specialist assistance; the committee will prepare a sample list based on its members and submit it to the BoD for evaluation and potential CLARIN-wide implementation
- CSC will review Jan Odijk's proposal concerning a structured approach to enhancing interoperability in CLARIN, and discuss its potential further submission to the BoD
- CSC will review the PARTHENOS Standardization Survival Kit and discuss it at one of the virtual meetings

Housekeeping matters

 needs to be updated, inactive members will be asked about their plans; the Committee intends on being maximally inclusive
- CSC will hold online meetings, the first one will be organized still in 2017 (doodle), topics:
 - Evaluation of the sample proposal of standards for text formats and decision concerning further extension
 - Evaluation of the sample questionnaire and report on members' fields of expertise; decision will be made on the submission of this template to the BoD for CLARIN-wide application
 - Evaluation of the proposal for "clarin.eu"-based namespace definition for use by ISO TC37SC4; decision will be made on whether to submit this to the BoD
